## Employment Guidance - Workshop: -

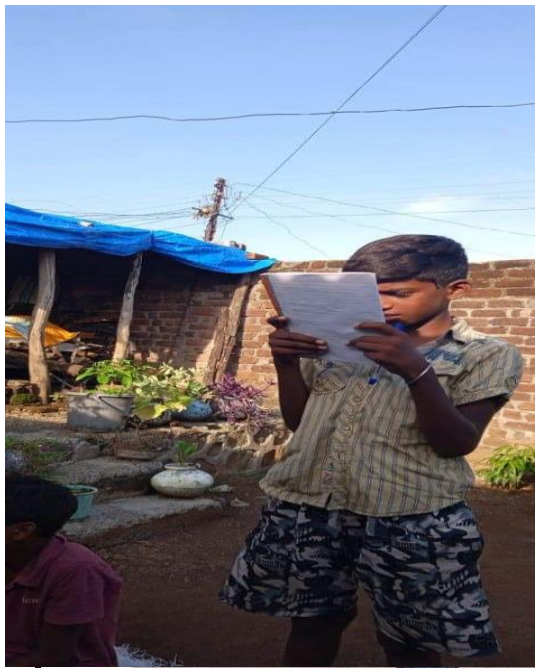
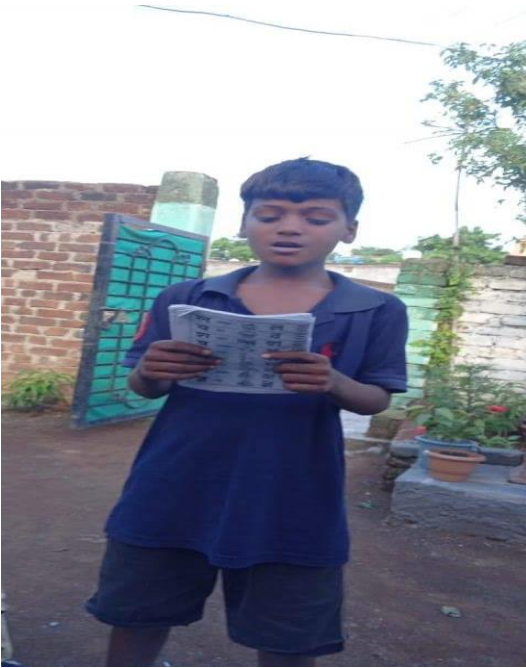
A workshop for Pardhi students was held at Vivekananda Hostel in November.2020. we have provided employment guidance.
